WHEREAS: the Town of Grand Falls-Windsor qualifies for funding under the

Provincial Water and Wastewater Initiative Fund;

WHEREAS: all spending under this Agreement must be used for the Exploits

Regional Water Supply Upgrades, Project #99-2018-6549;

AND WHEREAS: the Town of Grand Falls-Windsor has a funding shortfall in

Project #99-2018-6549 of \$72,770.41;

THEREFORE BE IT RESOLVED: that the Federal Gas Tax Fund – Provincial Water and Wastewater Initiative be amended to increase funding

for Project #99-2018-6549 by \$72,770.41 for a total allocation of \$609,348.07.

Be it resolved that the Tender for the Rehabilitation of the Exploits Regional Water Supply Dam #2018-G10 would be adopted as circulated. This motion carried by a vote of 6-0.

Mayor Manuel asked the Director of Engineering and Works to give us a summary of what the Gas Tax request and the Tender is for.

The Director of Engineering and Works advised that when we originally applied for Gas Tax that was the maximum amount we could get at that time. The Gas Tax Secretariat suggested that the best thing to do is to apply for more funding, but there is no guarantee that it will get approved. Time is of the essence because we only have until September to get this done as per Department of Fisheries and Oceans.

The Director of Finance and HR advised the total additional funding for this tender is about \$36,497.02 and that it is not just us that is in the region, so it would be sixty-five percent (65%) of the additional cost.

The Chief Administrative Officer\Clerk noted that in the event that it was not approved, we need to choose whether to use the unallocated Gas Tax money that has not yet been assigned to other projects or absorb the cost one hundred percent (100%). But we feel confidence that it will be supported.
